Public Comment

The Chairman asked for comments from the public.

Mr. Oscar McCoy from 73 Garland had a complaint regarding his extension agreement and requested to the Board provide an explanation of the bill. Mr. Walker requested Mr. Bateman to provide an explanation which he did. The matter was turned over to the Solicitor to contact the customer and resolve this issue.

Mr. Walker stated that he felt that the policies and procedures of the MUA needed to be examined and recommended a work session. No action was taken on Mr. Walker's suggestion.

Computer Security

Mr. Walker then introduced Timothy Guim the Authority's IT consultant. Mr. Guim provided an explanation of what happened regarding the security breach on the computers and what steps have been taken to ensure that the chances of it happening again would be minimized. The Board accepted the report but took no action.

Mr. Reiter arrived at the meeting.

Executive Director's Report

Mr. Walker requested Mr. Bateman to present his Executive Director's report.

Strategic Plan

Mr. Bateman explained that the updated strategic plan had been provided to the Board in early May. Mr. Bateman stressed this is the Commissioners opportunity to have a dialogue with the staff in setting the future course of the MUA. Mr. Reiter had a question concerning whether or not we were providing enough publicity to customers concerning the solicitations for water and sewer lateral repairs being made by private companies. Mr. Bateman explained that in the past announcements have been made in the newsletter and on the website. The Board postponed any action on the strategic plan until the July regular meeting. Mr. Bateman indicated he would add it to the July agenda.

Arbitrage

Mr. Bateman stated that the Authority had recently received correspondence from the Internal Revenue Service indicating that the authority owed money to the federal government for arbitrage. Mr. Bateman requested that Mr. Kiel present an explanation. Mr. Kiel provided an explanation and reviewed the history of the situation. Mr. Kiel felt as though the IRS was

incorrect in their conclusions. Mr. Kiel recommended that the situation be turned over to Bond Counsel. The Board concurred.

Leasing of Elevated Tank Space

Mr. Bateman reported that he had advertised for leasing space on top of the elevated tanks for cell antennas. There was no response to the advertisement.

Close out of New Connection Projects

Mr. Bateman provided a status report on efforts to close new connection projects and escrows.

He stated that significant progress has been made since the Board charged him with that responsibility. Mr. Campbell commended Mr. Bateman for his efforts. The Board concurred.

Sandy Relief Grants

Mr. Bateman provided a status report on the initiative he took to obtain \$7.5 million in grant money related to Sandy relief. The Board acknowledged Mr. Bateman's initiative.

Sale of Authority Property

Mr. Bateman announced that he had received bids for the sale of authority property. He requested that the Board wave the minimum bid for one of the printers because there was only one bid and it was below the minimum. The Board concurred and waved the minimum. Mr. Bateman reminded the Board that the items that were not bid upon would be offered to Willingboro charities or thrown out. The Board concurred.

Conference Attendance

Mr. Bateman requested permission to attend the AEA conference on health insurance and other HR topics. Motion was made by Mr. Campbell and seconded by Mr. Gray to retroactively

approve reimbursement for expenses related to this training. Vote:Mr. Campbell, AYE; Ms. Jennings, AYE; Mr. Scott, AYE, Mr. Gray, AYE, Mr. Reiter, AYE, and Mr. Walker, ABSTAINED.

Shut off fees

Mr. Bateman began a presentation concerning shut off fees. Mr. Walker suggested that this item be tabled. Mr. Bateman suggested placing this item on the July agenda. The Board concurred.

Treasurer's report

On behalf of Mr. Jacobs Mr. Bateman presented the bills for the Board's consideration. A motion was made by Mr. Reiter and seconded by Mr. Gray to approve the bills as presented.
