Ratifying and Authorizing the Extension of a Contract with Jersey Environmental Solutions to Provide S-3 Licensed Operator Services to the Pollution Control Plant on an Emergent Basis

Whereas there exists a need to supplement the workforce at the Willingboro Municipal Utilities Authority Pollution Control Plant ("WMUA PCP") with a licensed S-3 Sewage Treatment Operator as required to facilitate the operation of the WMUA PCP; and

Whereas the WMUA has received a directive from the NJDEP that a licensed S-3 Sewage Treatment operator is required or fines may be imposed; and

Whereas Jersey Environmental Solutions ("JES") is qualified to supply the services of a licensed S-3 Sewage Treatment Operator and has provided the service on a per diem basis since December 6, 2023; and

Whereas WMUA employees have not been able to obtain their S-3 Sewage Treatment Operator license to date and it has become necessary for the service to continue with JES; and

Whereas as per the attached memorandum, the Executive Director has determined that the WMUA must stay in compliance with the directives of the NJDEP and protect the public health, safety, and welfare of the WMUA clients by immediate delivery of the service; and

Whereas the lack of an S3 Sewage Treatment Operator creates an emergent condition as set out in the attached memorandum; and

Whereas funds are available for this purpose as indicated in the Certificate of Availability of Funds executed by the Director of Finance that is attached hereto.

Now, therefore, be it resolved by the Board of Commissioners of the Willingboro Municipal Utilities Authority, in the Township of Willingboro, County of Burlington, State of New Jersey, accepts the recommendation of the Executive Director to retain the services of JES on an emergent basis and hereby ratifies and authorizes the continuation of those services in an amount not to exceed \$70,000.

Authorizing The Execution Of An Amendment To The Energy Services Agreement With Schneider Electric All In Connection With The Authority's Energy Savings Improvement Program

Whereas, the Willingboro Municipal Utilities Authority (the "MUA") owns and operates water and wastewater production, treatment, and conveyance facilities located in the Township of Willingboro; and

Whereas on November 22, 2017, the MUA, pursuant to the competitive contracting provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-4.1 et seq., and the Energy Savings Improvement Program Law, N.J.S.A. 40A:11-4.6 et seq., issued a Request for Proposals to Select an Energy Services Company to Develop and Implement an Energy Savings Plan through an Energy Savings Improvement Program for the Willingboro Municipal Utilities Authority (the "RFP"); and

Whereas On June 20, 2018, as recommended in the evaluation report, dated June 15, 2016, the MUA selected, via Resolution, Schneider Electric Buildings Americas, Inc. ("Schneider") to serve as the MUA's Energy Services Company in connection with its Energy Savings Improvement Program ("ESIP"); and

Whereas, on April 16, 2020, Schneider provided the MUA with a final Energy Savings Plan, which has been reviewed and accepted by the New Jersey Board of Public Utilities and the MUA's independent third-party reviewer, Gabel Associates; and

Whereas, Schneider and the MUA have established three (3) distinct phases of the MUA's Energy Savings Plan: Phase I – Smart Meters; Phase II – ESIP and Other Process Improvements; and Phase III – Increase of High Strength Waste for Increased Methane Production; and

Whereas, the MUA and Schneider executed a Master Energy Services Contract, dated October 1, 2020, a copy of which is attached hereto as Exhibit A, to implement Phase I (Smart Meters) and Phase II (ESIP and Other Process Improvements) of the approved Energy Savings Plan (the "Energy Services Contract"); and

Whereas, the Energy Services Contract value of the Phase I improvements totals approximately \$7.2 million and the value of the Phase II improvements totals approximately \$17.2 million; and

Whereas, Schneider was required, pursuant to Article 1 (Substantial Completion) of the Energy Services Contract, to complete all Phase I and Phase II work, as stated in the Scope of Work. by February 1, 2023; and

Whereas despite working diligently to complete all Phase I and Phase II work by February 1, 2023, Schneider has been subject to significant delays related to certain work being financed through the New Jersey Infrastructure Trust and the associated review of contract documents by the New Jersey Department of Environmental Protection; and

Whereas the aforementioned minor field (site) modifications shall not be excessive and shall result only in minor price increases to the originally awarded contract price but in no event shall exceed \$7,500: and

Whereas the Executive Director shall file with the Board through the Board Secretary with a copy to the Chairperson, a request in writing for the change order, stating the facts involved and indicating that the proposed change order may be allowed pursuant to N.J.A.C. 5:30-11et seq (attached) as may be amended and supplemented, and if the request and justification are prepared by other than the Executive Director, they must be countersigned by the Executive Director; and

Whereas no change orders for changes in quantities, work performed, services rendered, materials, supplies or equipment delivered or provided shall be authorized, permitted, or accepted unless in accordance with the "Local Public Contracts Law" and by the attached procedures established in N.J.A.C.5:30-11 et seq (which may be amended and supplemented from time to time or unless otherwise directed by a Local Finance Notice); and
